2. The Vendor has the absolute right to withdraw from the sale of any or all specified residential property at any time before the acceptance of any offer or to sell or dispose of any or all of the specified residential properties or any part of it to any person by any method (including without limitation private treaty, tender and auction).
3. The Vendor has the absolute right to accept any tender submitted at any time before the tender closing date and time.
4. The Vendor has the absolute right to change the closing date and/or time of the tender from time to time by amending this Information on Sales Arrangements and is not obliged to separately notify any potential tenderers or persons of such adjustment.

5. Persons interested in submitting tenders of the specified residential properties are reminded to read the latest register of transactions of the Development so as to ascertain whether a particular specified residential property is still available for tender on a date of sale. A specified residential property will become unavailable for tender once the Vendor accepts a tender after the close of a previous tender exercise of that specified residential property (whether under this Sales Arrangements or any other Sales Arrangements, if applicable) (if any). Please note also that the register of transactions of the Development may not be updated immediately after the Vendor accepts a tender.
 6. Notwithstanding anything herein provided, in case a black rainstorm warning signal or a typhoon signal no.8 or above is announced between 9:00 a.m. and 12:00 p.m. on the said closing date of the tender, the tender closing date and time will be extended to 12:00 p.m. on the next working day as defined in the Conditions of Sale.
 7. The Vender might impose precautionary measures and crowd control at the Sales Office under the consideration concerning health and security. Any person who does not comply with the instruction and measures of the Vender might be refused entry.
 8. In the event of any discrepancy between the English and Chinese versions of this Sales Arrangements, the English version shall prevail.
